Our Contract With You

Changes to These Terms and Conditions or the Search My Credit Services

We may change these Terms and Conditions or the Search My Credit services at any time. The changes will take effect when they are posted on the searchmycredit.co.uk website.

If You don't want to continue to be registered on the searchmycredit.co.uk website or to continue to get the Search My Credit services then You can cancel Your registration/membership by letting Us know in writing by e-mail to customerservice@searchmycredit.co.uk.

Registration

Before You can use the Search My Credit services You must apply to use the Search My Credit services. Part of this process is registering via the apply now page on the searchmycredit.co.uk website. After We have received Your application for the Search My Credit services We will review it and let You know as soon as We can whether You have been accepted as a user of the Search My Credit services. Please note that not everyone that applies for the Search My Credit services will be accepted as a user.

We do not have to notify You why You have not been accepted, but one reason for this may be that, at the time You make Your application, We may have been unable to match Your personal details to the correct credit report. We are constantly seeking to improve Our matching service and if We are subsequently able to match You to the correct credit report We may invite You to be a user of the Search My Credit services.

You may only register and use the Search My Credit services if You are 18 years of age or over. By registering on the searchmycredit.co.uk website and making the application to use the Search My Credit services You confirm that You are 18 years of age or over.

You may only use and access the Search My Credit services on Your own behalf and not on behalf of anyone else. You should be aware that You cannot order credit information about anyone else from this website.

Once We have received Your application for the Search My Credit services We will send You an automated acknowledgement. This is purely for acknowledgement purposes and is not an agreement from Us to provide You with the Search My Credit services or any other service.

Credit Report

Your credit report will be provided by Callcredit Consumer Limited. The credit report will be updated daily. Credit reporting services are supplied and powered by CallCredit Consumer Limited.

By agreeing to this service and wishing to access your report you are also required to accept Callcredit Consumer Limited's terms and conditions as it is supplying the credit report that you, the consumer will have access to as part of the Search My Credit services.

Credit Rating

Your credit report is based on information that Callcredit Consumer Limited hold about You. This assessment will be available to You online via Search My Credit login, and will be based in part on Your history of borrowing and repayment. Credit reporting services are supplied and powered by CallCredit Consumer Limited.

Alerts

When You have successfully registered on Our site you will be notified of any changes, via the email address You supply when You register with Search My Credit. If there is any dispute on the information held on your credit report the customer should contact Callcredit Consumer Limited.

Search My Credit does not provide you with your credit report, this is provided by CallCredit

Consumer Limited and can be accessed via the Search My Credit website. Search My Credit does not hold and cannot access your credit report.

The Search My Credit Services are only available to customers who live in the UK.

Whilst We will try to make sure that the searchmycredit.co.uk website is available for use as much as possible We cannot guarantee its availability.
